TDSP Monthly Charges are the fixed charges from the transmission and distribution service provider and are passed through without mark-up. TDSP Delivery Charges include all recurring consumption charges from the TDSP and are passed through without mark up.

Your average price per kWh each month is determined by using the energy charge above and the predetermined formula

Price per kWh = (Base Charge + (Monthly billed kWh usage x Energy Charge) + (Free Days kWh usage x \$ 0.00) + CenterPoint Energy Monthly Charges + CenterPoint Energy Delivery Charges + \$0.00 CenterPoint Energy Free Days Delivery Charges)/ Monthly billed kWh usage

*Free Flex Days are the two (2) highest usage days each week, up to a total of eight (8) Free Days per monthly billing period that is 28 days or longer. For billing period of fewer than 28 days, Free Days shall be prorated as follows:

- 1-3 billing days = 0 Free Flex days
- 4-6 billing days = 1 Free Flex day
- 7-13 billing days = 2 Free Flex days
- 14-20 billing days = 4 Free Flex days
- 21-27 billing days = 6 Free Flex days
- 28+ billing days = 8 Free Flex days

Free Flex Days will be allocated first to full weeks, then split between partial weeks, if applicable. Weeks will be counted from Sunday to the following Saturday. A day is defined as the 24-hour period beginning at midnight through 11:59 p.m.

This price disclosure is an example based on average service prices - your average price for electricity service will vary according to your usage.

In the event Reliant receives incomplete interval data from your Transmission and Distribution Service Provider (TDSP), Reliant may estimate your usage for missing periods based on historical data from your meter. A multi-day average of recent interval data will be used to estimate usage for missing intervals and the estimates will be used to calculate your monthly bill. When there is a difference between the monthly meter read and the monthly total of the actual or estimated interval data, the usage difference will be allocated based on your usage profile for that billing period. If less than 50% of the interval data is received from the TDSP or is estimated by Reliant, the usage difference between the monthly meter read and monthly total of the actual or estimated interval data will be applied as 32% at the Free Days Energy Charge and 68% at the Energy Charge.
